## **Event Terms and Conditions**

By purchasing a ticket for the Great Mancunian Ball you agree to the following terms and conditions:

- Tickets are available to purchase at £5,000 or £10,000 for a table of ten.
- Further ticket price points may be introduced by the organisers during the period of sale.
- Tickets will be emailed to the lead contact no less than five working days ahead of the event.
- It is the responsibility of the customer to inform us of any change of address, contact phone number or email address, both before and after receipt of the goods.
- Once purchased, tickets cannot be exchanged, refunded or returned unless the event is cancelled, moved to another date, or if details of the event are significantly changed after an order is placed.
- If St Ann's Hospice has to cancel the event, our liability in the event of cancellation is limited to a full refund of the event fee only.
- We will not refund any travel or hotel costs associated with the cancellation of an event.
- You will be requested to confirm dietary requirements on request and no less than one month ahead of the event. Failure to communicate dietary requirements within this time will result in the standard meal option being presented.
- 'unlimited wine and beer' and 'unlimited beer, wine and spirits' applies throughout the period of time that the meal is served from arrival at tables until dessert is served.
- St Ann's Hospice is unable to accept liability for any injury, loss or damage, however arising, or for cancellation of the event for any reasons outside our control.
- An age restriction (18 years of age) applies to this event. Please ensure that you read all the information that applies to the event/ticket you are booking, and carry proof of age if appropriate
